The Italian Mandate

Italy has one of the largest VAT gaps of any EU Member State, standing at a staggering 35 Billion euros in 2015.

In an effort to combat fraud and tax evasion, the Italian government has adopted a Clearance Model tax system.

Under the new system, all invoices must be submitted for registration, in a pre-defined XML format, through the online government platform, the Sistema di Interscambio (SdI), before becoming a legal tax document.

1 July 2018

For all companies supplying gasoline or diesel fuel intended for use as a motor fuel and sub-contractors of suppliers to public administration.

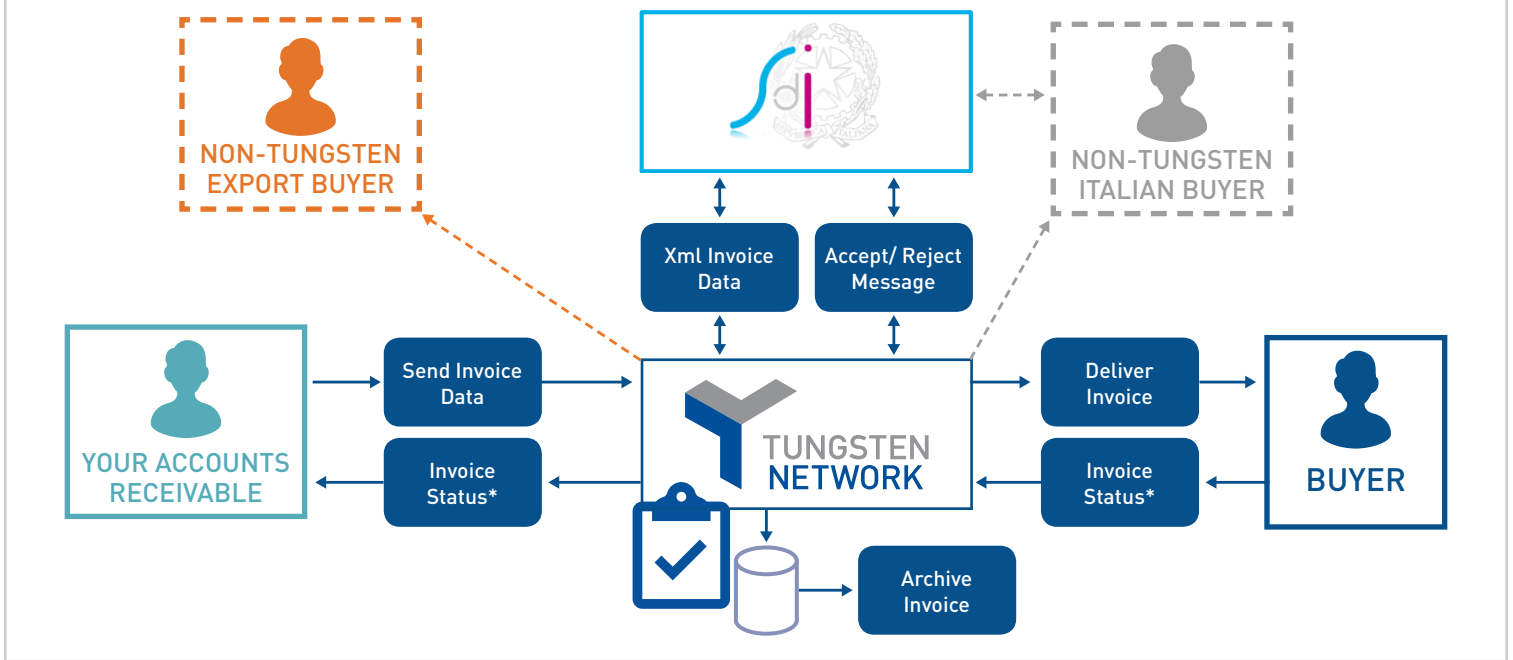
1 September 2018

For all "Tax Free Shopping" invoices – those invoices issued for supply of goods to private customers residing outside the EU

1 January 2019

The general mandate for all B2B and B2C transactions comes into force.

Accounts Receivable Data Flow

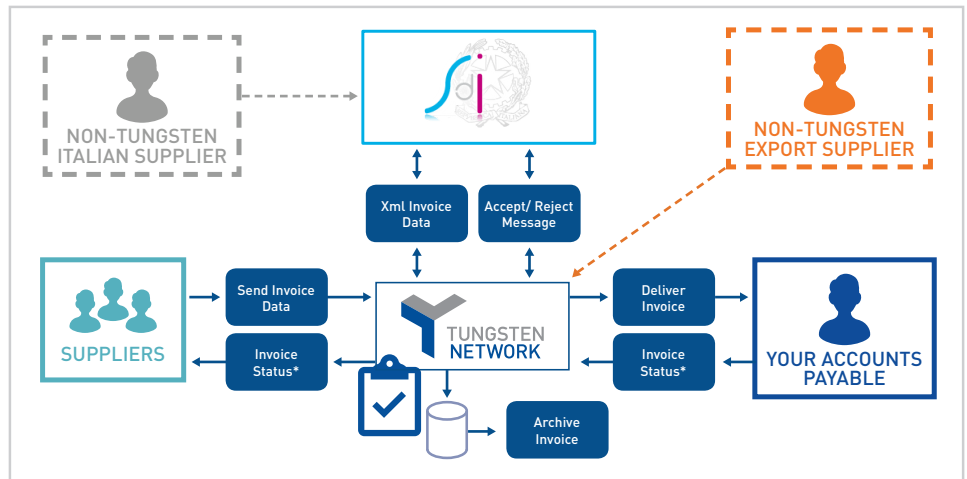


Compliance in your Accounts Payable Department

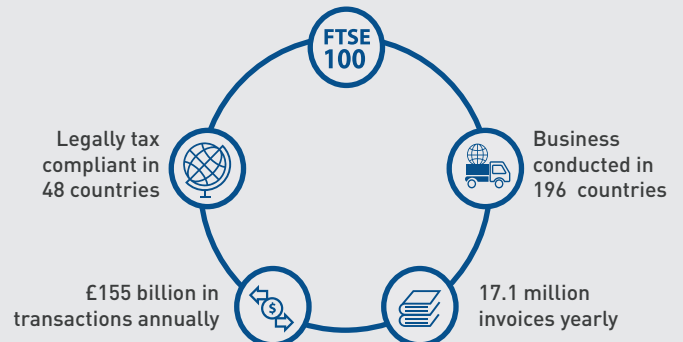
